Comments: IN ADDITION TO THE ABOVE LOCAL SCHEDULE THAT AIRED ON WKRC-TV (ANALOG AND DIGITAL SIMULCAST), WE ALSO AIRED THE FOLLOWING PSA AND CST CONTENT GENERATED BY THE CBS NETWORK: 29 PSAS AND 81 CSTS (6-9AM 14 PSAS; 6-11:35PM 12 PSAS AND 25 CSTS). ALTHOUGH NOT REQUIRED BY FCC REGULATIONS, WKRC AIRED A SIMILAR SCHEDULE OF PSAS AND CSTS ON ITS SECONDARY DIGITAL CHANNEL, A CW AFFILIATE KNOWN AS EKRC. DURING THE QUARTER EKRC AIRED 212 PSAS AND 229 CSTS OF THAT NUMBER 44% OF THE PSAS AND 46% OF THE CSTS AIRED BETWEEN 6 PM AND 11:35 PM. IN ALL, WKRC MET OR EXCEEDED FCC'S REQUIREMENTS DURING THE THIRD QUARTER FILING PERIOD.
